Home Sellers Staying Firm on Asking Prices

Nearly 75% of REALTORS® report that their sellers have not lowered listing prices to attract buyers during this time, according to a new survey conducted April 19-20 by the National Association of REALTORS®. This suggests home sellers are avoiding “panic selling” during the COVID-19 pandemic, the survey notes.

“Consumers are mostly abiding by stay-in-shelter directives, and it appears the current decline in buyer and seller activity is only temporary, with a majority ready to hit the market in a couple of months,” says NAR Chief Economist Lawrence Yun. “The housing market faced an inventory shortage before the pandemic. Given that there are even fewer new listings during the pandemic, the home sellers are taking a calm approach and appear unwilling to lower prices to attract buyers during the temporary disruptions to the economy.”

Sales are still happening. A survey released last week from NAR showed a quarter of REALTORS® reporting that their clients had put contracts on homes without physically seeing the property.

More than a quarter of REALTORS®—or 27%—report that they are able to complete nearly all aspects of transactions while respecting social distancing. The most common technology tools that REALTORS® report using to connect with clients during this time are e-signatures, social media, messaging apps, and virtual tours.

Test Centers Openings:

PSI plans to reopen Owned and Operated test centers in the United States on May 1, 2020 based on jurisdictional analysis to determine each state's allowance and/or restrictions for operating. Ohio sites are planned for reopening on May 1st.

Sites will reopen meeting social distancing standards, at reduced capacity to allow for candidate spacing. **Please note that scheduling options may be limited as a result.** PSI will evaluate demand daily to plan for extra hours as needed.

All health and safety requirements have already been implemented. All test center closures can be found here. Please be aware that the reopen dates listed are tentative. PSI is in contact with all sites and will update these dates as needed.

Reminder-Face Masks and Gloves:

If a candidate chooses to wear a face mask and/or gloves, the candidate will be required to bring those items with them to the test center. **NOTE:** Candidates will be required to comply with specific state, city and county requirements as it relates to the use of face masks. Also, there are 3rd party sites that are requiring the use of face masks and the candidates may be turned away if they are not in compliance.

Face masks will need to be removed during check-in process to verify identity of the candidate, take their photo and to allow the Test Center Administrator to ensure there is no writing or hidden materials in or on them.

Candidates are responsible for disposing of used face masks and gloves securely outside of the test center.

Please reach out directly to PSI with questions. PSI will be reaching out to reschedule those candidates who were previously scheduled and could not test due to the Stay Home Order.
